#### THE SERVICE MINUTE OF THE SRI LANKA EDUCATION ADMINISTRATIVE SERVICE - AMENDMENT No. 1

7.2.1.1 (a) is hereby amended as follows :

a. Recruitement to the General Cadre

Must hold a degree obtained from a university recognized by the University Grants Commission or an institution recognized by the University Grants Commission as a degree awarding institution.

7.2.1.1 (b) is hereby amended as follows :

b. Recruitment to the Special Cadre  
(Information Technology and Bio-systems Technology)

Must hold a degree in the prescribed subject in respect of the subjects of Information Technology and Bio-systems Technology from a university recognized by the University Grants Commission or an instituion recognized by the University Grants Commission as a degree awarding institution.

7.2.1.1 (c) is hereby amended as follows :

c. Recruitment to the Special Cadre  
(Engineering Technology Subject)



Must hold an engineering degree in any of the fields of Mechanical, Construction, Electrical and Electronic from a university recognized by the University Grants Commission or an institution recognized by the University Grants Commission as a degree awarding institution or the four-year Higher National Diploma in Engineering (HNDE) awarded by the Sri Lanka Institute of Advanced Technology or the four-year Diploma in Engineering Science (NDES) awarded by the Institute of Engineering Technology, Katunayake.

7.3.2.1(a)(i) is hereby amended as follows :

(a) General Cadre

Educational qualifications

(i) Must be teacher holding a degree obtained from a university recognized by the University Grants Commission or an institution recognized by the University Grants Commission as a degree awarding institution or National Institute of Education.

7.3.2.1(b)(i) is hereby amended as follows :

(b) Special Cadre

(i) Educational Qualifications

Must be a teacher holding a degree in the prescribed subject, obtained from a university recognized by the University Grants Commission or an institution recognized by the University Grants Commission as a degree awarding institution or National Institute of Education.

Line 15 of Schedule b titled “technology” (including Bio-systems Technology and Engineering Technology) is amended as follows :

<i>Subject Area</i>	<i>Qualifications for Recruitment</i>
15. Technology	
(i) Bio-systems Technology	Holding a degree in Agricultural Science or the Trained Teacher’s Certificate or the National Diploma in Teaching in Home Science, Agricultural Science, Handicraft and Life Skills.
(ii) Engineering Technology	A degree in Technology obtained from a recognized university or an institution recognized by the University Grants Commission as a degree awarding institution for the subject of Engineering Technology or an Engineering Degree in any of the fields of Mechanical, Construction, Electrical and Electronic obtained from a recognized university or an institution recognized by the University Grants Commission as a degree awarding institution or the four-year Higher National Diploma in Engineering (HNDE) awarded by the Sri Lanka Institution of Advanced Technology or the three-year National Diploma in Technology (NDT) awarded by the University of Moratuwa or the four-year Diploma in Engineering Science awarded by the Institute of Engineering Technology, Katunayake or the Diploma in Technology (DT) awarded by the Open University of Sri Lanka or the Higher Diploma awarded by the institutes approved by the Tertiary and Vocational Education Commission of Sri Lanka, which is equivalent to Level 6 of the National Vocational Qualifications (NVQ Level 6)
