- M.Sc. (Wood Science & Technology): B.Sc. degree with Physics. Mathematics and Chemistry or B.Sc. degree in Forestry. The candidate having 50% or above marks may apply.

• M.Sc. (Cellulose & Paper Technology): B.Sc. degree with minimum 50% marks in aggregate in Science with Chemistry as one of the subjects. BE/ B.Tech. (Chemical or Mechanical Engineering with minimum 50% aggregate).

Candidates from South Asian countries are exempted from appearing in the M.Sc. admission test provided they have passed the above mentioned eligibility requirement from a University outside India and fulfill the following conditions.

- The candidates must have a valid residential permit in India granted for studies/ students Visa for the prescribed duration of the concerned courses,
- The antecedents of the candidates must have been verified by the local Government/ Govt. of India and found in order.
- The candidate must have a certificate to be verified by the Ministry to the effect that candidates had been subjected to AIDS test and found negative,
- 4. The degree/certificate of the candidates must have been approved by the Association of Indian Universities (AIU) or equivalent to the corresponding degrees/certificates of the AIU.
