Absorption to the Teacher Advisors' Service

As per the provisions in the Service Minute No.2182/36 dated 01.07.2020 of the Teacher Advisors' Service and in my Circular No.21/2020, all the officers who have been absorbed to the Teacher Advisors' Service from 01.07.2020 and who have submitted applications expressing their consent to be absorbed will be absorbed to the Teacher Advisors' Service in accordance with the amendment of the Service Minute of the Teacher Advisors' Service published in the Extra-ordinary Gazette No.2300/09 dated 04.10.2022 as follows.

02. These revised provisions are applicable to all the teacher advisors who have been absorbed to the Teacher Advisors' Service as at 01.07.2020, and who are in the service as of 02.01.2022 and have submitted applications expressing their consent to be absorbed.

I. Teacher Advisors who received letters for absorption

- The actions will be taken to cancel the letters of absorption of all Teacher Advisors who are in the service as of 02.01.2022 and have already been absorbed to the Teacher Advisors Service, and the arrangements will be made to absorb those officers to the Teacher Advisors Service to be effective from 02.01.2022.
- Accordingly, the actions will be taken to cancel the previous letters of absorption and to issue new letters in due course.

II. Teacher Advisors not received the letters of absorption

- If there are teacher advisors who have expressed their consent to be absorbed to the Teacher Advisors' Service and have not yet received such letter of absorption, the arrangement will be made to absorb such officers to the Teacher Advisors Service to be effective from 02.01.2022.
- Accordingly, the actions will be taken to issue the letters of absorption in due course.

III. Service period up to 02.01.2022 in respect of the Officers subject to absorption as per these provisions

- a. With regard to all the officers who are in the service as of 02.01.2022 and have expressed consent to be absorbed to the Teacher Advisors Service from 01.07.2020, the actions will be taken as per the provisions in the previous service minute applicable for those officers till 02.01.2022.

IV. Teacher Advisors who have been retired from the Teacher Advisors' Service before 02.01.2022

- a. The absorption date of the teacher advisors who have been retired before 02.01.2022 and have expressed their consent for the absorption to the teacher advisors' service will further be considered as 01.07.2020.

V. Revising the date of absorption to the Teacher Advisors' Service as per the provisions of this Circular.

- a. An officer who is in the service as of 02.01.2022 and have expressed consent to be absorbed to the Teacher Advisors Service will be given an opportunity to further consider the date of absorption to the Teacher Advisors' Service as 01.07.2020 at his/her discretion. An officer having such a need should submit an application on that matter together with an affidavit to the Secretary of the Ministry of Education through the Zonal Director of Education within 03 months from the date of issuance of this Circular.

03. As per the provisions stipulated herein, only the date of absorption to the Teacher Advisors Service is revised and all other provisions of my Circular No.21/2020 remain unchanged.

04. Decision on the matters not covered by this Circular will be taken by me with the approval of the Public Service Commission.

05. In case of any inconsistency between the language texts of this circular published in Sinhala, Tamil and English languages, the Circular in Sinhala will be considered correct.
