01. Qualifications

- i. Should be a Grade 01 Officer of the Sri Lanka Education Administrative Service.
- ii. Should have completed a satisfactory and active service period after being promoted to Grade 01 of the Sri Lanka Education Administrative Service.
- iii. Should have completed all the qualifications as at or before the closing date of applications.

02. Method of Application.

- i. Duly filled applications prepared in A4 size papers in accordance with the specimen application attached herewith should be sent by registered post to the address of **“Assistant Secretary, Education Services Establishments Branch, Ministry of Education Isurupaya, Battaramulla** “on or before **12.12.2022**. - ii. Recently taken colored photograph of you in the size of 2” x 2¹/₂” should be affixed at the top- right corner of the application.
