### ABOLITION OF SCHOOL DEVELOPMENT BOARDS

School Development Boards' proclaimed by His Excellency the President and Minister of Education and Higher Education by Gazette (Extra-ordinary) No. 701/12 of 12th February 1992 shall cease to operate from 2. 1. 1995 in respect of all Schools. The School Development Societies which have been in operation, prior to the establishment of School Development Boards will mutatis mutandis perform the functions assigned to the School Development Boards.


My Circular No. 19/1993 of 29 th September 1993 bearing reference No. 3/SD/3/5/93 is hereby repealed.

Funds of the school Development Boards established under article 09:01 of Circular No. 19/1993 should be transferred to the Accounts of the School Development Societies. All collections made as services and facilities fees, should be credited to the facilities fees account from 2. 1. 1995 as was done prior to the establishment of School Development Boards.

Operation of the accounts of the School Development Societies should be in accordance with Provisions of School Development Societies Circular No. 1982/2 of 30. 3. 1982 as amended by Circular No. 2/SD/3/8/6/91 of 15. 10. 1993. If any further amendments are deemed necessary in the Circular pertaining to School Development Societies, such amendments will be made by mw in due course.

If a School Development Board at the time of its dissolution was engaged in any construction work, having entered into a contract with the Government or a Provincial Authority under the Special concessio granted to School Development Boards to enter into contracts up to Rs. one million, School Development Societies of the Schools concerned will be permitted to complete such work. However, from 2. 1. 1995 normal tender procedure should be followed in regard to all contracts.
