**Implementation of the New Service Minute of the Sri Lanka Teacher Educators' Service**

It is notified that the Public Service Commission has granted the approval for making the following Provisions applicable to the officers absorbed to the Sri Lanka Teacher Educators' Service Minute published in the Gazette No. 1925/37 dated 28.07.2015.

- The increments of the officers who were recruited to Class 3 in terms of the old Service Minute No. 1070/13 dated 11.03.1999, and whose increments have been suspended due to the non - completion of the First Efficiency Bar will be suspended until the completion of the First Efficiency Bar of the new Service Minute No.1925/37 dated 28.07.2015.
- The increments of the officers who were recruited to Class 3 in terms of the old Service Minute No. 1070/13 dated 11.03.1999 and whose increments have been suspended due to the non - completion of the Second Efficiency Bar shall be paid from 28.07.2015, the date on which the new Service Minute came into operation.
- If the officers who were recruited to Class 3 in terms of the old Service Minute No. 1070/13 dated 11.03.1999 but not promoted to Grade 2-II due to the non - completion of the link language requirement and not earned increments due to stagnating in the maximum of the salary point of the relevant column have obtained a satisfactory or a higher level of performance during the said period of service, the



service period of such officers should be deemed as a part of the period of satisfactory period.

- iv. If the officers who were absorbed to Class 3 in terms of Section 18 of the old Service Minute No. 1070/13 dated 11.03.1999 have completed the written examination of the Efficiency Bar related to Grade 2 – II of the same Service Minute, such officers should be deemed as officers who have completed the Second Efficiency Bar related to the officers in Grade II of the new Service Minute No. 1925/37 dated 28.07.2015.
- v. Since the related subject field has provided with delay to the officers recruited to the class 3 in 2000/2001 in terms of the old Service Minute No. 1070/13 and dated 11.03.1999, obtaining a post graduate degree should be deemed as a promotion qualification instead of the qualification stated as “having obtained a post graduate degree in Education or any other relevant subject” as it is applied only for them.
