Marking Scheme of the Structured Interview to recruit the officer for the Post of Chief Commissioner (Teacher Education) at the Ministry of Education - 2024

01. Seniority

Maximum marks: 45

In addition to the satisfactory service period of not less than 05 years in Grade I of the Sri Lanka Education Administrative Service (SLEAS) as mentioned in Basic Qualifications in terms of the Service Minute of Sri Lanka Education Administrative Service, the marks will be awarded as the officers are entitled for the marks per year in terms of the active and satisfactory service period in Grade-I of the Sri Lanka Education Administrative Service, the officer with highest service period in Grade I gets the total marks allocated as per Public Service Commission Circular No. 01/2019, and the other officers get the marks proportionally for their additional period of service.

Note - In respect of the officers who have been promoted to Grade I subsequent to the completion of 12 years of active and satisfactory service period in Grade II and III with a service period of two (02) years in Grade II of the Sri Lanka Education Administrative Service, their active and satisfactory service period additional to the said total service period of 12 years and two years in Grade II will also be considered as a service period in Grade I and the marks will be awarded accordingly.

02. Educational Qualifications

Maximum Marks: 15

Marks are given only for the qualifications obtained by a university recognized by the University Grants Commission (UGC) or by an institution recognized as a degree awarding institution by the UGC or National Institute of Education.

(No marks shall be given for the educational qualifications that have already been considered as a basic qualification for the recruitment, efficiency bar examination or Grade promotions.)

(In awarding points under the above clauses 2.6 and 2.7, Academic period should be at least more than 450 hours or 09 months and the institution awarding the diploma must be a registered institution of the Government or the University Grants Commission (UGC) or the Tertiary and Vocational Education Commission (TVEC)

03. Knowledge on Computer Literacy

Maximum Marks: 05

(Practical use shall be considered. A power point presentation should be presented with a computer as mentioned under sequential No.07 herein and shall also be assessed the capability of doing another task with the office package as intended by the Board of Interview)

04. English Language Proficiency

Maximum Marks: 05

(Communication Skills shall be considered. Capability of speaking, responding with accurate answers upon the questions raised after reading and comprehending any text and ability to answering for questions shall be assessed)



05. Researches and Publications related to Education

Maximum Marks: 10

- 5.1. Researches
 - i. Individual Research Reports Marks 5 x 2
 - ii. Group Research Reports Marks 3 x 2

(No marks are awarded for the researches / theses submitted for the Post Graduate Degree/ Post Graduate Diploma and marks are awarded only for the research reports submitted for a Research Symposium or published in a Research Journal)

5.2. Books and Journals - Marks 5 x 2

(No marks are awarded for the publications in text books and affiliated reference books and only the books and journals having individual authorship and approved by the Educational Publications Advisory Board will be considered for awarding marks)

- Marks will be awarded only for maximum two researches and /or books.
- 5.3. Marks will be given for maximum of 05 as two (02) mark each for reports and academic compendiums submitted for educational publications.

06. Service Appreciations

Maximum Marks: 05

Marks will be given for 05 service appreciations as 01 mark per each only for Appreciations of Service issued methodically by the Secretary to the Ministry of Education or the Head of the Institute in the Form General No.230B - Commendations and Censures relevant to Sri Lanka Education Administrative Service in respect of programmes / projects implemented for the progression in the education field

Note: Head of the Department means Chief Secretary to the Provincial Council, Secretary to the Provincial Ministry of Education, Commissioner General of Examinations, Commissioner General of Educational Publications, Provincial Director of Education or Zonal Director of Education,

07. Presentation Maximum Marks: 10

Marks will be given as follows for a presentation done on the basis of and by analyzing a fact/ an instance / programme / project that was fundamental to upgrade the quality and efficiency of the Education System when the duties are fulfilled at the Service Station (Ministry of Education / Department of Education of Sri Lanka / Department of Education Publications/Provincial Department of Education / Zonal Education Office/Divisional Education Office/School)
