# Appointment of the Officers in Grade I of the Sri Lanka Teacher Educators' Service to the Posts – 2024

The applications are called from the eligible Grade I officers of the Sri Lanka Teacher Educators' Service by order of the Education Service Committee of the Public Service Commission to be appointed to the posts at the Kuliyapitiya National College of Education under the Ministry of Education in terms of the direction given by the Education Service Committee of the Public Service Commission and instruction given by the National Election Commission by the letter No.EDR/PRE/2024/D-297 and 09<sup>th</sup> August 2024 issued by the Additional Election Commissioner and the applications prepared according to the specimen format given at the end of this notice should be sent in registered post to the "Assistant Secretary, Teacher Educators Branch, Ministry of Education, Isurupaya, Pelawatta, Battaramulla" on or before the date given below. The caption "Appointment of Grade I Officers of the Sri Lanka Teacher Educators' Service to the posts 2024 should clearly be mentioned on the top left hand corner of the envelop.

#### 02. Method of Selection:

- I. As per the paragraph 11 of the Service Minute of the Sri Lanka Teacher Educators' Service published in the Extraordinary Gazette No. 1925/37 dated 28.07.2015 of the Democratic Socialist Republic of Sri Lanka, the applications for the above posts are called from the eligible officers, and the appointments to the posts are done by the Education Service Committee of the Public Service Commission considering the preference of the applicant, the service requirement and the recommendation of the Secretary to the Ministry of Education on the basis of the ranks upon the marks obtained by the candidates in a structured interview conducted by a panel of interviewers appointed by the Education Service Committee of the Public Service Commission.
- II. As per the Schedule V of the Service Minute of the Sri Lanka Teacher Educators' Service, only the officers who obtain the minimum pass mark of 35 or more at the structured interview shall be selected for the appointment to the relevant posts.
- III. The method of awarding marks for the structured interview has been given in the schedule I of this notification.

- IV. The service stations and the posts desired to be applied should be mentioned under the paragraph 08 of the application according to the order of preference. If you do not get qualified to be appointed to an applied post by the merit order, giving appointment to another service station on the service requirement can be considered.
- V. Duties must be assumed mandatorily for which you are appointed since no opportunity is given to the officer to be refused assumption of duties for which already appointed.
- VI. No opportunity is given to be altered the preference order mentioned in the application at a later occasion.
- VII. Appointment to post in accordance with the merit obtained at the interview shall be considered for this stage only.
- VIII. Applications must only be submitted by the Apprentices who wishes to be studied at the National College of Education, Kuliyapiya by those who have already applied for this apprenticeship recently as stated in terms of the section 08 of the previous application.
- IX. If an applicant is revealed not to have the required qualification or if any particular furnished by an applicant is found to be false after the selection or if any wrong fact has been deliberately suppressed by him/her, he or she is liable to be dismissed from the post.

### 03. Qualifications:

- I. A Grade I officer who has passed 03<sup>rd</sup> Efficiency Bar Examination of the Sri Lanka Teacher Educators' Service.
- II. Should have been completed an active and satisfactory service during last precedent 05 years by the date of calling these applications.
- III. All the qualifications should have been completed on or before the closing date of applications.
- 04. The relevant structured interview is held at the Ministry of Education, Isurupaya, Battaramulla. The date of the interview shall be notified later. The determination of the Education Service Committee of the Public Service Commission on making appointments to these posts shall be the final and conclusive decision.
- 05. In the event of any inconsistency among the Sinhala, Tamil and English language texts of this notification, actions shall be taken by considering as the Sinhala text shall is true and accurate.
