Please be advised that only applications duly completed and received by this office no later than 2:00 p.m. on 21st October 2025, accompanied by all requisite documents, will be considered for processing. Applications submitted after this deadline or those found to be incomplete will not be accepted under any circumstances. Kindly note that the deadline for submission will be strictly enforced.
- O7. Please note that all nominations will be forwarded to JICA for their consideration. As part of the evaluation process, JICA will conduct selection interviews based on the contents of the respective GIs. The decision of JICA shall be regarded as final and binding.
- 08. Please be aware that any discrepancies in the names of nominees across different documents may result in administrative complications and delays in processing. Therefore, nominees are strongly advised to use their names exactly as they appear in their passports in all documentation related to the programme.
- 09. We would highly appreciate your support in identifying the most suitable and deserving candidates for this invaluable opportunity extended by JICA to the Government of Sri Lanka and we look forward to receiving a strong list of nominations.
- 10. Your early response in this regard is highly appreciated.
