Subject: Training slots under the India Technical & Economic Co-operation (ITEC) Scholarship Scheme of the Ministry of External Affairs, Government of India for the year 2025-2026 for training in India

Dear Sir,

I am pleased to convey that the Government of India has announced the upcoming training courses to be offered under ITEC for months of February and March, 2026. A detailed list of training courses which scheduled from the 1st of February, 2026 onward, is attached for your reference. Please note that normally there are 02 slots available for each programme for Sri Lanka. You are requested to send 3-4 nominations for each programme, so that in case any candidate drops out, other may be immediately approved as a replacement for proper utilization of available slots.

2. Government of India will provide the following facilities to participants for these ITEC Courses —

- Return air ticket from Colombo to Training Institute in India
- Course fee
- Accommodation
- Living allowance of INR 1500/- per day for meeting expenditure on food
- Medical expenses (only in case of medical emergency during their training in India)
- Approved study tours

3. It may kindly be noted that all applicants are required to apply for ITEC courses online (<https://www.itecgoi.in/meaportal/registerApplicant>) – (Apply for ITEC courses). The applicants can choose their own login email ID and create their login password, which would be used by the system to keep them posted of the status of their application. The programme has already been published on the ITEC portal.


4. After a candidate has submitted application online, he/she must take a printout of the application and send it to the **Department of External Resources of Sri Lanka** with all supporting documents. Incomplete applications will be rejected. The terms and conditions and guidelines for applicants are attached in Annexure – II.

5. A medical certificate issued by the doctor/hospital (Government Hospitals) should be attached with the application to ensure that the participant is medically fit to undertake the course in India.

6. As ITEC programmes are offered for capacity building, I request you to circulate these courses to all relevant personnel and making use of this opportunity. You are also requested to ensure that duly filled approved **applications are sent at least 10 days in advance**, so that necessary formalities can be completed well in time.

General Instructions for applicants

1. Eligibility criteria for admission to Courses -
 - Working knowledge of English required to follow the Course
 - **Age between 25 to 50 years**
 - Medically fit to undertake the training
2. **Applicants who have previously completed an ITEC course are eligible to apply only if the earlier course was completed more than five years prior to the commencement date of the current course.**
3. It may kindly be noted that all applicants are required to apply for ITEC courses online (<https://www.itecgoi.in/meaportal/registerApplicant>) - (Apply for ITEC course). The applicants can choose their own login email ID and create their login password, which would be used by the system to keep them posted of the status of their application.
4. After a candidate has submitted application online, he/she must take a printout of the application and send it to the **Department of External Resources of Sri Lanka** with all supporting documents. Incomplete applications will be rejected. The terms & conditions and guidelines for applicants are attached at Annexure -II (available on the ERD website).
5. A medical certificate issued by the doctor/hospital (Government Hospitals) should be attached with the application to ensure that participants are medically fit to undertake the course India.
6. Upon selection, the High Commission of India will inform the Nodal/designated Department/Agency and the candidate.
7. Selected candidates are required to familiarize themselves fully with the living conditions in India and about the Institute through the Institute's website.
8. **Decision regarding acceptance of applications/nominations rests solely with the Ministry of External Affairs, Government of India.**
